1. All pigs are donated by the Cheshire Fair Association.
2. Application and entry fee must be received prior to 4:00 PM, Friday, July 31, 2009 at the Main Office at the fairgrounds. Applications may be mailed to the Cheshire Fair Association, Inc., 247 Monadnock Highway, Swanzey, NH 03446
3. Applicant must be a NH resident and 8-12 years old as of Jan. 1 of the current year.
4. Contestants will be selected randomly from applications received. Only one application is allowed per person; duplicate applications will result in disqualification.
5. Contestants will be provided with a burlap bag to put the pig in.
6. When a contestant is holding onto the animal no other contestant may attempt to catch that same animal.
7. Pig will be considered caught when it is in the bag & the bag is brought to the fence to be tied.
8. When the pig is caught, it becomes the property of the contestant, who is responsible for the health and condition of the animal. Owner must make arrangements for safe and humane treatment of pig following the scramble.
